Sealed bids on forms furnished by the Town of Strafford (Owner) will be received until **2:00 PM Thursday, August 9, 2013**, at the office of the Town Clerk, Town of Waitsfield, 9 Bridge Street, Waitsfield, VT 05672. This project is situated as follows:

LOCATION: Beginning near the northern abutment of the cover bridge

on Bridge Street (TH #1) on the northern bank of the Mad River. The project extends approximately 550' upstream to the old dam.

CONSTRUCTION BEING: Placement of Type IV stone fill to stabilize the river bank and landscaping as shown on sheets C0.01, C0.02, C1.01, C1.02, L1.01, C3.01, and C5.01 (7 Sheets).

PRE-BID MEETING: A mandatory pre-bid meeting will be held on Monday, July 29, 2013, 3:00 PM, at the Bridge

COMPLETION DATE: The contract shall be completed on or before October 1, 2013, with substantial completion by September 15, 2013.




