ITINERANT STREET VENDOR ORDINANCE

No person shall engage in the business of an itinerant street vendor within the corporate limits of the Village of Waitsfield without first holding a current Vendor's license from the State and secondly applying for and receiving a license from the Town. The license fee shall be in conformity with the schedule as shown on the application and shall be valid for one year ending December 31st. Such licensed vendor may employ one or more persons who may engage in the business of vending for his employer under license.

- a) Itinerant street vendors are defined as any persons, whether a resident of the Town of Waitsfield or not, traveling by foot, wagon, automotive vehicle, or any other type of conveyance from place to place, carrying hot or cold food, refreshments, offering and exposing the same for sale, or making sales and delivering such products to purchasers or who without traveling from place to place, shall sell or offer the same for sale from a wagon, automotive vehicle, or other vehicle or conveyance. This does not include those persons making sales of such products to commercial establishments.
- b) The provisions of this section shall not apply to persons engaged in selling meats, poultry, eggs, butter, fruits or vegetables which are raised or produced by him.
- c) Authorized representatives of religious, charitable, and educational or service organisations desiring to solicit money or distribute literature shall be exempt from this ordinance.
- d) No licensee under this ordinance shall interfere in any manner whatsoever with the ordinary passage in or use of the streets. Also such licensee shall be responsible for the control and disposal of all waste matter caused by his activity.
- e) Any person who shall engage in the business of an itinerant street vendor, either as principal or agent, within the corporate limits of the Town of Waitsfield without first obtaining the license required under this ordinance shall be fined not more than \$50.00 for each day that he shall engage in such business without such license.

- C. If travelling or transporting goods by motor vehicle with capacity not exceeding one and one-half tons, fee is \$50.00.
- D. If travelling or transporting goods by motor vehicle with capacity exceeding one and one-half tons, fee is \$100.00.
